Blair MacDonald, Chair and VP, Chelsea Foley attended the Annual Provincial SAC Conference in September.

The EECD requested SAC participation in the following 24-25 initiatives: Consultation on the Provincial Code of Conduct, EECD Local Voice Survey and a Thought Exchange.

Part of the SAC involvement includes SSP changes and updates, Principal reports on teacher professional development and evidence of student learning. SAC members ask questions about and make suggestions for improvement and reasons/benefits of expenditures are discussed/approved.

A SAC goal in 2024-25 was to support classroom teachers with initiatives and/or resources to support the SSP goals in math, literacy and well being. Teachers were asked to submit requests explaining the purpose of the items/materials and what curriculum areas each supported. Upon reviewing the requests, the SAC members approved each purchase. This included items for loose parts play, integrated content areas, UFLI workstations, computational fluency activities, technology, French board games. The purchase of 29 books to complete the creation of grade specific mentor texts aligned with each outcome in science, social studies and health was also made. These purchases increase student engagement while supporting the SSP goals.
